Where people fall below the standards of practice and conduct we can investigate and take action.

- register people working in social services and make sure they adhere to the SSSC Codes of Practice
- promote and regulate the learning and development of the social service workforce
- are the national lead for workforce development and planning for social services in Scotland
- are an ONS statistics provider.

**The SSSC has been involved with a number of initiatives concerning trauma informed practice. For example, we have:**

- trained staff in our Fitness to Practise department in trauma and adverse childhood experiences to gain a better understanding of the effect trauma can have on survivors and how it may affect their ability to give evidence and its quality.
- supported the development of the Scottish child interview model and have endorsed the associated training . We are looking at how we build this into our new Continuous Professional Learning (CPL) model for social workers and also how it is included in the development of an advanced practice framework for social workers being developed by OCSWA.
- Continued to endorse the National Trauma Training Programme materials as evidence of CPL requirements and we are working with Scottish Government to develop further trauma skilled and enhanced level resources for social workers.
- have made a commitment in our people strategy to become a trauma informed organisation and will be training all staff
- staff with training in joint investigative interviews to get the best possible evidence from children and vulnerable witnesses without causing them undue stress or anxiety.
- developed procedures about taking evidence from vulnerable witnesses.
